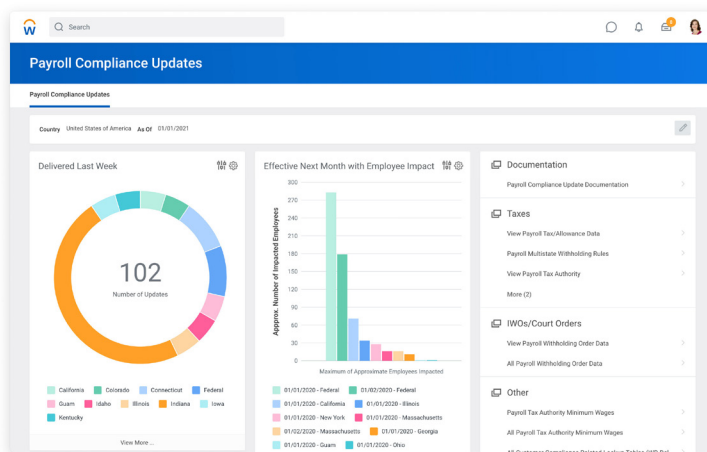
### A Smarter Way to Manage Compliance

## Seamless Payroll Compliance

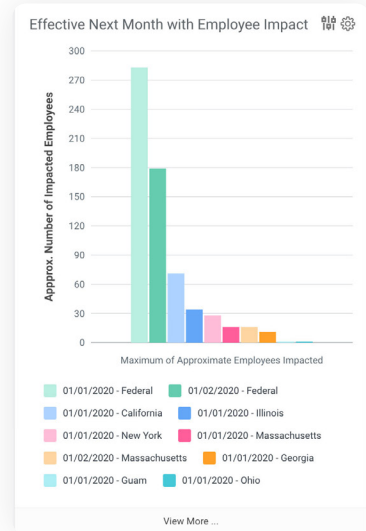
